{Yacht\_name} as shown on the attached map,

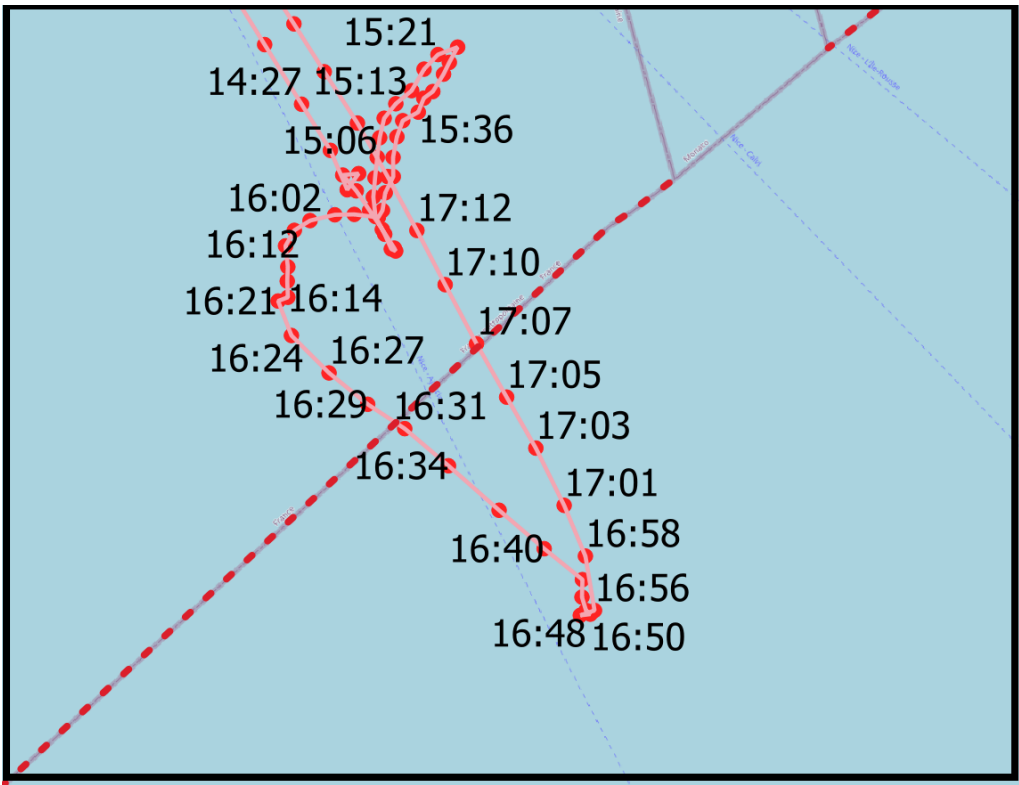
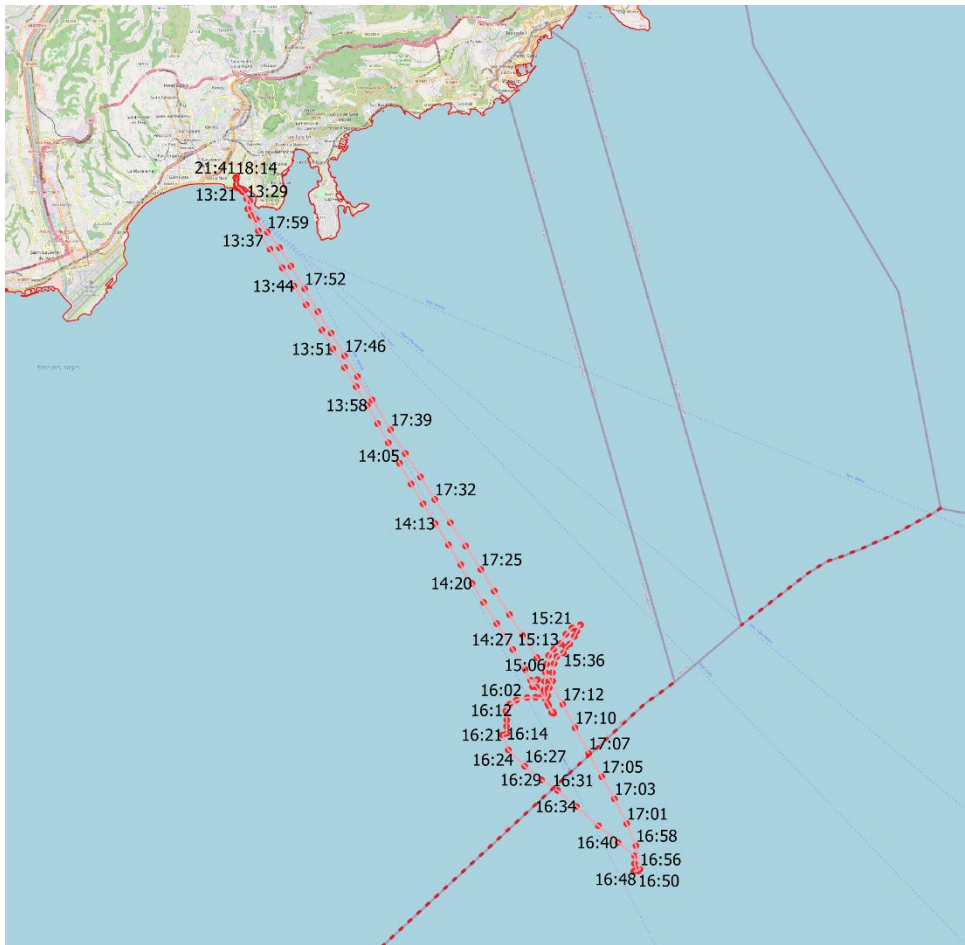
We noted that {Yacht\_type} {Yacht\_name} entered international waters on **25/03/2021
